President looks forward to a busy year ahead with OFA





Brad and Tara Peacock farm 1,500 acres of rice, soybeans and corn in White County, Arkansas. Brad also helps manage an additional 2,000 acres of the family farm. He's the fifth generation to farm in his family. He graduated with Bachelors in Ag Business from AR Tech University in 2009. Shortly after, he met his wife, Tara, and the two married in 2012. Tara is the Art Director at Think Idea Studio in Searcy. The Peacocks have a four

year old son, Silas.

"We're very thankful we were able to participate and meet so many people at NOYF who we foresee will be lifelong friends. I said it many times during our time in Appleton, but we didn't feel like this was a competition. It was an opportunity to connect with like-minded people across agriculture. We learned, we laughed and we ate more cheese than we've ever had in our lives! Now we get to



go back to our communities across the US inspired and proud of what we accomplish together."









NOYF WINNER'S SPOTLIGHT Carl and Betsy Long (PA 2023)

Carl and Betsy Long of Coudersport, Penn., are first generation farmers. Along with their children, Mark (14), Emmett (12), and Colette (8), they own and operate a 2,600-acre grain and vegetable farm. Carl's interest in agriculture started with an opportunity to work on his science teacher's dairy farm. His involvement in 4H and FFA helped grow his passion for farming. While in high school, Carl obtained a FSA youth loan and started his farming career. Immediately after high school, Carl was able to secure a processing sweet corn contract to grow 90 acres on rented land. The following year Carl connected with a farmer that wanted to retire and was able to assume his processing green bean contract, rent his ground, and purchase some of his equipment. In 2006, Carl purchased this farm. The next year he married Betsy. She has assumed most of the record keeping for the farm: payroll, food safety plan, and worker protection standard. Betsy keeps track of the miles and gallons to prepare the IFTA, HUT, and KYU for the farms three semis.

After tough weather years and changes in markets, the Longs decided to try growing potatoes. They found them to be an excellent fit for their climate/soils and began to focus on potatoes. They currently raise 415 acres

of potatoes for chipping and sell them to 11 different potato chip factories. The Longs worked with Penn State and PA Cooperative Potato Growers to host variety research plots on the farm. This resulted in them finding a russet variety that was well suited for their farm, and are continuing to develop this russet market. In addition to potatoes, the Longs also raise processing green beans, winter wheat, seed oats, clover, timothy, and corn. They follow conservation plans on all their farms and notill all of their winter wheat into green bean stubble. Due to the hilly terrain that they farm, much of their ground is farmed in 120 foot wide contour strips.

The Longs credit much of their success to the relationships that they have built. Long Farms is truly blessed to have the support of family, friends, employees, landowners, and our community. They have received so much help from the people they do business with: from the people they buy fertilizer, chemicals, seed, and parts from to

the brokers that work tirelessly to sell their crops.

We were very humbled and honored to be nominated as National Outstanding Young Farmers. During our first Zoom meeting, we were told we would make new lifelong friends. It was hard to believe until we arrived in Appleton. The family of the OFA was apparent from the time we landed and continues as we write this. The quality of the entire NOYF Class of 2023 was amazing! Each one has a passion for agriculture, and is doing great things for their communities. We are very fortunate to have found these new friends. We left Appleton and returned to the farm rejuvenated and inspired by spending our time with such an amazing group of people.

NOYF MEMBER'S SPOTLIGHT Nate & Brooke Youngquist (WA 2016)

We are excited to host the OFA in Washington in 2024, the congress hasn't been held in our state, ever! We don't have many OFA members in Washington and are grateful to have the support and assistance of John and Morgan Morrison to help in preparations and hosting. We enjoyed getting to know John and Morgan at the 2023 congress and are looking forward to this once in a lifetime opportunity to host you all in our backyard.

Since our NOYF congress in 2016, Nate's business has transitioned from a retail and wholesale berry operation to farming 800 acres of ornamental gourds, pumpkins and organic hard squash. This winter Nate has been busy updating the warehouse with state-of-the-art equipment to automate washing and painting lines, as well

as processing and packing to help automate and increase production. In addition to warehouse updates, he has been busy adding a few new team members to his growing business in the areas of Finance and Operations.

We are quickly approaching planting season where 25 different varieties of gourds, pumpkins and squash will be planted for an August and September harvest. Beginning the harvest as early as possible in August allows for the product to be washed and painted (if applicable) and to be packed and shipped nationwide to retail chains across the country to have it on store shelves in September and October. Be sure to look out for the label Bay Baby Produce this fall.

While Nate farms on the commercial

scale, Brooke has stayed busy taking over their yard with her small-scale seasonal flower farm specializing in dahlias and other cut flowers grown from seed. Since she also works remotely in Human Resources, Mountain View Blooms has grown slowly primarily selling directly to local florists and flower shops for weddings and events

After an unusually cold and wet spring in 2022 we are hopeful for a more normal spring planting season. The spring and summer months are always a busy time for all of us in Ag, and our family is no different. Adding even more to our plates this year we are eager to welcome baby number 2 in June.




